









## **AMENITIES MAP**








#### **WILLIAMS**

A community of approximately 5,300 people located at the crossroads of Interstate 5 and State Route 20, 60 miles north of Sacramento and mid-way between the Sierras and Pacific Coast. Located in the heart of Sacramento Valley, Williams is an agriculturally oriented community. Rice, tomatoes, walnuts, almonds, hay, grain, and cattle are raised in the area surrounding the city. Williams is the gateway to the Northern California hunting and fishing mecca. It's located in Pacific Flyway for duck and goose season. The nearby foothill regions provide deer, elk and wild boar. The Sacramento River, 10 miles east, provides Salmon, Striper, Steelhead and Sturgeon fishing.


